THAT the Bank be furnished with the Trust Deed of the Pension Scheme (for sighting purposes only), together with a list (see overleaf) containing full names, addresses and specimens of the signatures of the Trustees of the Pension Scheme or a memorandum in lieu signed by at least two Trustees of the Pension Scheme and that the Bank be informed by notice in writing, signed by at least two Trustees and as soon as may be, or any change taking place from time to time in the Trustees of the Pension Scheme.
